

## Unit 163 Motion Log for 2016

Please refer to Unit 163 Board meeting minutes for more details.

All motions are assumed to have passed, unless specifically stated otherwise.

16001F. MaryAnn Boardman was appointed as an authorized signer of the Iowa State Bridge League checking account at West Bank. Gary Edwards, Secretary/Treasurer, is also an authorized signer.

16002F. The 2016 budget was approved.

16003T. Starting times for Unit 163 Sectionals:

Weekdays: 10:00 a.m. and 3:00 p.m.; or, 1:00 p.m. and 6:00 p.m.

Saturday: 10:00 a.m. and 3:00 p.m.; or, 9:00 a. m., 1:00 p.m., and 6:00 p.m.;

or, 1:00 p.m. and 6:00 p.m.

Sunday: 10:00 a.m. with play through.

16004T: "The ISBL has no zero tolerance policy" was deleted from Unit 163 policies. Unit 163 now agrees with ACBL policy regarding zero tolerance.

16005T: The Special Events Guide was approved and will be posted on the Unit 163 web site.

16006T: A motion was made to increase entry fees for Unit 163 Sectionals from \$8 to \$9.

16007T: Motion 16006T was tabled, pending more research. At the August 27 board meeting, motion 16006T was defeated. Entry fees will remain at \$8.

16008T: A motion was made to require all Unit 163 Sectionals to offer two sessions of Regionally Rated Charity Games, at a cost of \$1 per person. The motion failed.

16009T: 75 or more bidding boxes will be purchased from District 14 for \$5 each.

16010T: Unit 163 will allow District 14 to use Unit 163's designated sanction for May to hold a combination /sectional and District 14 GNT final. The dates for 2017 are May 5 – 7, 2017, in Mason City.

16011B: Any club that has held a charity game for an ACBL fund is encouraged to hold a charity game for the designated local charity of Multiple Myeloma or a local charity of their choice in October.

16012T: This cancels the sanction for the Spring Waterloo – Cedar Falls Sectional to allow the combined Unit 163 Sectional and District 14 GNT final in Mason City from May 5 7, 2017.

16013L: The Hall of Fame Policy will stay the same as listed in the Policy Manual, and the board will be more judicious in following that policy. The Membership Committee will review the policy.

16014M: The Awards Game will become a regular part of the tournament schedule, and will be held on the last Saturday in February. The 2017 game will be held in Glovik Hall in Cedar Rapids.

16015M: This approves one ACBL and one Unit Charity game in October. Unit 163 will reimburse ACBL charity fees and promote the event with clubs.

16016T: Donna Lombardini and GS Jade Barrett were given approval to hold a NLM Sectional in Unit 163, with Unit 163 receiving 30% of the profit. This date was later set for December 13 – 14, 2016 in Waterloo.

16017F: Gary will dispose of the old card tables. Tables now in possession of clubs will become their property.

16018F: A motion to require Directors to use ACBL hand records, duplicate all boards, and provide hand records at all Unit 163 Sectionals was tabled.

16019B: The Regional Selection sub-committee was given authority to sign a contract for the 2018 Regional. A contract has now been signed with the Radisson in Coralville for the dates June 25 – July 1, 2018.

16020F: Unit 163 property may be loaned to other District 14 Units by the authority of the President or the Secretary/ Treasurer. A deposit may be required.

16021M: Unit 163 Sectionals that increase tournament attendance by 10% over the previous 3 years average will receive a party provided by Unit 163, to be held at a local club. The local club will be chosen by the Tournament chairperson.
